- ✓ There is an adequate supply of disposable PPE, as per specific task requirements, and all staff provided with instruction in the correct use and fitment:
  - Public Health England and NHS YouTube video, COVID-19: putting on and removing personal protective equipment (PPE) – a guide for care homes
- ✓ PPE provided, as required following specific current guidance for the protection of COVID-19 detail type and standard, as applicable:
  - Disposable half face mask
  - Disposable gloves
  - Disposable aprons
  - Where personal care is to be provided eye protection/surgical face mask

Posters displayed in prominent areas and toilets.</li> <li>✓ Staff kept informed via email, online meetings etc.</li> <li>✓ Post-incident de-briefing carried out for anyone involved in an incident of suspected contamination, with the aim of providing support and preventing incident recurrence. 			<ul style="list-style-type: none"> <li>✓ Face masks no longer need to be worn, however school may advise staff and/or pupils to wear a face mask in crowded corridors, poorly ventilated areas or areas where close contact with others is unavoidable.</li> <li>✓ Signage installed to various areas of the building reminding people to wash hands regularly, in line with Government guidance.</li> <li>✓ Corridors, walkways and staircases have markings laid out to indicate side to walk on (two way traffic).</li> <li>✓ Staff verbally reinforce controls in corridors, walkways and stairwells where necessary.</li> <li>✓ Wipes and cleaning materials available in staff rooms for staff to clean regular contact points e.g. kettle, taps etc.</li> <li>✓ Water fountains should only be used with refillable bottles.</li> </ul>

Staff should transfer calls rather than pass handsets to colleagues. Where this is not possible, callers are provided with an alternative number to call back.</li> <li>✓ The use of copiers, printers and shredders is for essential school use only. Where it is essential to use such devices, they should be cleansed after each use. Appropriate signage is installed to advise users accordingly and cleaning materials are available.</li> </ul>	LOW

Critical information is cascaded to other staff.</li> <li>✓ Wherever possible, meeting rooms should be adequately ventilated with external windows opened during meetings.</li> <li>✓ Whole school meetings (e.g. inset day) to be held in as large a space as possible to allow for adequate distancing of attendees: <ul style="list-style-type: none"> <li>• Attendees encouraged to take LFT test on the morning of the meeting prior to attending.</li> <li>• If adequate spacing between attendees cannot be achieved, the wearing of face coverings is encouraged.</li> </ul> </li> <li>✓ Meeting room users advised not to share equipment during meetings i.e. pens, stationery etc. Attendees to remove all items following the meeting.</li> <li>✓ Meeting room users to wipe down surfaces (including any buttons on IT equipment and remote controls) following meetings. Additional cleaning materials will be provided in all meeting rooms for use by staff and replenished as required.</li> <li>✓ Meetings to take place promptly and conclude fully in the meeting room to avoid attendees congregating in adjoining areas prior to and following meetings.</li> <li>✓ Meeting room should be aired thoroughly on completion of the meeting e.g. opening windows fully.</li> <li>✓ Parent group meetings: <ul style="list-style-type: none"> <li>• Parent group meetings to be held in as large a space as possible to allow for adequate distancing between attendees.</li> <li>• If adequate spacing between attendees cannot be achieved, the wearing of face coverings is encouraged.</li> <li>• School encourages the use of outdoor space for parent groups where</li> </ul> </li> </ul>	LOW

6	COVID-19: Dining areas	Staff Pupils	<ul style="list-style-type: none"> <li>✓ Dining room tables and chairs will be wiped down between sittings.</li> <li>✓ Dining room windows will be opened to allow natural ventilation.</li> </ul>	LOW/ MED

7	COVID-19; Cleaning	<p>Staff</p> <p>Pupils</p> <p>Visitors</p> <p>Contractors</p>	<ul style="list-style-type: none"> <li>✓ All cleaning staff are experienced and have received appropriate training.</li> <li>✓ Any new cleaning products brought on site in response to the current COVID-19 pandemic will have a COSHH risk assessment undertaken prior to use.</li> <li>✓ Cleaners have appropriate PPE in line with COSHH risk assessments</li> <li>✓ Classroom play equipment wiped down and cleansed at the end of the school day and between activities where possible.</li> <li>✓ Cleaning undertaken in line with Government publication COVID-19: cleaning in non-healthcare settings.</li> <li>✓ School will be fully cleaned at the start/finish of each school day.</li> </ul>	LOW/ MED
			<p>Cleaners on site throughout the school day and regularly touched items such as door handles, handrails etc. will be regularly wiped down and cleaned.</p> <p>Staff clean own classroom areas/ toilets etc regularly throughout the day.</p> <ul style="list-style-type: none"> <li>✓ Classrooms where a pupil or staff member has become symptomatic during the school day will be deep cleaned along with other areas the person may have been. 8	COVID-19; Ventilation	Staff Pupils Visitors Contractors	<ul style="list-style-type: none"> <li>✓ Staff are encouraged to open windows and doors (not fire doors) to encourage as much natural ventilation as possible.</li> <li>✓ When leaving a classroom empty, windows should be opened fully to purge the room then left ajar when the room is re-occupied.</li> <li>✓ Desk type fans can be used to promote fresh air flow from an open window.</li> <li>✓ Fans should not be used in poorly ventilated areas.</li> <li>✓ Prior to the receipt of CO2 monitor re Government roll out: potentially poorly ventilated areas identified, including all areas where people work/teach and have large groups within, that have no mechanical or natural ventilation.</li> </ul>	LOW/ MED
9	COVID-19; Pupils and staff who become symptomatic during the school day	Staff Pupils Visitors Contractors	<ul style="list-style-type: none"> <li>✓ Pupils and Staff who become symptomatic during the school day will be isolated from the rest of the pupil group and their parents (pupils) will be called to come and collect them. Staff will be sent home to self-isolate/follow public health advice. <a href="#">Studio used as isolation area, with PPE available</a></li> <li>✓ If a symptomatic pupil is awaiting collection, appropriate PPE should be used if close contact is necessary.</li> <li>✓ Any areas, items and surfaces the symptomatic person has come into contact with should be thoroughly cleaned as soon as possible.</li> <li>✓ Symptomatic pupils and staff are advised to engage with NHS Test and Trace and get tested and to follow the current advice.</li> <li>✓ Staff and pupils with a positive LFT test result should self-isolate in line with</li> </ul>	

			<p>COVID-19 guidance for household with possible coronavirus infection. A PCR test will be required to check the LFT test result.</p> <ul style="list-style-type: none"> <li>✓ If PCR test is taken within 2 days of the positive LFT test, and is negative, it overrides the LFT test and they can return to school, as long as they are not symptomatic.</li> <li>✓ School should complete online MDS form if there is a confirmed case associated with their setting <a href="https://www.smartsurvey.co.uk/s/covid-19-schools/">https://www.smartsurvey.co.uk/s/covid-19-schools/</a></li> <li>✓ School should contact local authority SPOC team if they have a positive case.
